Include price for air entrainment (5.5% (+ / -) 1.5%)
Fly ash in mix is not acceptable
Water / cement ratio (lbs. / lb.) - 0.46
Slump - 4.00"
Concrete unit weight (PCF) - 144
The 6 sack mix to have a minimum compressive strength of 4000 PSI at 28 days

All bids must be received no later than March 10, 2023, at 11:00 a.m. and will be opened at that time.

All **mailed** or **carrier delivered** sealed bids, subject to the Instructions and General Conditions of Bidding listed below and any special conditions set forth herein, will be received at the Office of the County Commission, Callaway County Courthouse, 10 East Fifth Street, Fulton, Missouri 65251, until 5:00 p.m. on Thursday, March 9, 2023. **Hand delivered** sealed bids will be received in the office of the County Commission until the scheduled time of opening. The sealed bids shall be for furnishing the Callaway County Road and Bridge Department with the material and / or list of materials, supplies, equipment, or services shown on the attached sheet (s). Proposals shall include all charges for delivery, packing, etc., to Fulton, Missouri.

The concrete bid is scheduled to be opened at 11:00 a.m. on Friday, March 10, 2023, in the County Commission Chambers, County Courthouse, 10 East Fifth Street, Fulton, Missouri 65251.

INSTRUCTIONS AND GENERAL CONDITIONS OF BIDDING

1. The Callaway County Commission has the right to accept or reject any part or parts of all bids, to waive technicalities, and to accept the offer the County Commission considers the most advantageous to the County.
 2. Bidders must give the unit price, extended totals, and sign the bid. Identify your bid by number, article, and opening date on the outside of the envelope the bid is sent in.
 3. Identify the item you will furnish by brand or manufacturer's name and catalog numbers. Furnish specifications and descriptive literature.
 4. When products or materials of any particular producer or manufacturer are mentioned in our specifications, such products or materials are intended to be descriptive of type or quality and not restricted to those mentioned.
 5. Do not include Federal Excise Tax or Sales Taxes in bid process, as law exempts the County from them.
 6. The County Commission reserves the right to cancel all or any part of orders if delivery is not made or work is not started as guaranteed. In case of delay, the Vendor or Contractor must notify the County Clerk, or in the case of a Road and Bridge Bid, the County Engineer or County Commission.
 7. In case of default by the Bidder or Contractor, the County of Callaway will procure the articles or services from other sources and hold the Bidder or Contractor responsible for any excess cost occasioned thereby.
 8. Failure to deliver as guaranteed may disqualify Bidder from future bidding.
 9. Prices must be stated in units of quantity specified, and must be firm. Bids qualified by escalator clauses may not be considered unless specified in the bid specifications.
 10. No bid transmitted by fax machine will be accepted.
 11. Failure to comply with any of the above instructions and general conditions of bidding may disqualify the bidder.
 12. The County of Callaway, Missouri expressly denies responsibility for, or ownership of, any item purchased until same is delivered to the County and is accepted by the County Commission.
 13. Unless otherwise noted, bid prices shall be good for one year after the award date.
