Now on this day the Callaway County Commission is accepting sealed bids on vehicle and equipment lubricants and fluids for the Road and Bridge Department. This bid will be for a one-year period beginning April 1, 2024 through March 31, 2025, at which time this bid shall be let again.

Vehicle and Equipment Lubricants and Fluid Specifications and the units for each bid item are provided or referenced within this bid package:

**15W40 multi-wt. for trucks / diesel - per 55 gallon drum - (must meet CJ-4 plus specifications and must be approved for extended drain)**

**Synthetic Blend Motor Oil - 5W20 - per 12 quart case**

**SAE 40 wt. Synthetic—per 5 gallon bucket**

**75/90 wt. Synthetic—per 5 gallon bucket**

**Hydraulic Oil - per 55 gallon drum - (Must meet John Deere Hy-Guard and CAT TO-2 or higher)**

**Hydraulic Oil – per 55 gallon drum - Universal TDH**

**Multi-purpose gun grease - per 10 tube case & per drum, 120lb.**

**Anti-freeze – (Red) - per 55 gallon Pre-Mixed drum - Extended life Anti-Freeze (must meet International BI Type III and CAT EC-1 specifications)**

The sealed bids shall be for furnishing the Callaway County Road and Bridge Department with the material and / or list of materials, supplies, equipment, or services shown on the attached sheet(s). Proposals shall include all charges for delivery, packing, etc., to the Callaway County Road and Bridge Department Office, 5901 County Road 302, Fulton, Missouri 65251.

**The bid is scheduled to be opened at 11:00 a.m. on Monday, March 11, 2024, in the County Commission Chambers, County Courthouse, 10 East Fifth Street, Fulton, Missouri 65251.**

### **INSTRUCTIONS AND GENERAL CONDITIONS OF BIDDING**

1. The Callaway County Commission has the right to accept or reject any part or parts of all bids, to waive technicalities, and to accept the offer the County Commission considers the most advantageous to the County.
2. Bidders must give the unit price, extended totals, and sign the bid. Identify your bid by number, article, and opening date on the outside of the envelope the bid is sent in.
3. Identify the item you will furnish by brand or manufacturer's name and catalog numbers. Furnish specifications and descriptive literature.
4. When products or materials of any particular producer or manufacturer are mentioned in our specifications, such products or materials are intended to be descriptive of type or quality and not restricted to those mentioned.
5. Do not include Federal Excise Tax or Sales Taxes in bid process, as the County is exempted from them by law.
6. Delivery date/time frame must be stated on bid sheet.
7. The County Commission reserves the right to cancel all or any part of orders if delivery is not made or work is not started as guaranteed. In case of delay, the Vendor or Contractor must notify the County Clerk, or in the case of a Road and Bridge Bid, the County Engineer or County Commission.
8. In case of default by the Bidder or Contractor, the County of Callaway will procure the articles or services from other sources and hold the Bidder or Contractor responsible for any excess cost occasioned thereby.
9. Failure to deliver as guaranteed may disqualify Bidder from future bidding.
10. Prices must be stated in units of quantity specified, and must be firm. Bids qualified by escalator clauses may not be considered unless specified in the bid specifications.
11. No bid transmitted by fax machine or email will be accepted.
12. Failure to comply with any of the above Instructions and General Conditions of Bidding may disqualify the bidder.
13. The County of Callaway, Missouri expressly denies responsibility for, or ownership of, any item purchased until same is delivered to the County and is accepted by the County Commission.
14. Unless otherwise noted, bid prices shall be good for one year after the award date.
